Editorial guidelines

- 1) Articles submitted to the journal should comprise original, unpublished material and should not be under consideration for publication elsewhere.
- 2) Manuscripts should be submitted through the web-based tracking system: <http://www.francoangeli.it/riviste/sommario.asp?IDRivista=107&lingua=en>
We recommend that authors consult the guidelines for referees (see below) before making their submissions.
- 3) Do not forget to upload the copyright transfer agreement (see Attachment A)
- 4) Electronic submission will require that you upload an anonymized version of your article to be evaluated by referees.
- 3) An abstract in English is required. Do not exceed **1.000-1.400 typing** .
- 4) You should include n. **6 keywords** in English.
- 5) Each article, including footnotes and references section, should be **between 30.000 and 40.000** typing (please consider the space necessary for tables and graphs), unless you had specific recommendations by the monograph editor(s). **The article cannot exceed 15 pages length.**
- 6) For papers based on empirical investigation, the research aims and objectives should be clearly stated, and the research questions or hypotheses clearly specified. The criteria for selecting the sample should be clearly described, and the characteristics of the sample described. Any statistical methods used for analysis should be clearly described. Moreover, any limitations of the study design should be addressed
- 7) **Font Type**
 - **Text:** Times New Roman, size 11 points, justified aligned, single spacing
 - **Title of the article:** Times, size of the text 16, left aligned
 - **Title of the section:** Times, size 11, bold, left aligned
 - **Footnotes:** Times, font 9 points, justified aligned, single spacing
 - **References:** Times, font 10 points, single spacing.

9) Reference system

All references cited in the text must be listed in the reference section, and vice versa.

11) Layout of the text

Each article should be in A4 size (to select A4, click Page Setup on the File menu).

The text has to be set up according to the following features.

Top margin cm 5,5

Bottom margin cm 6,2

Left margin cm 4,6

Right margin cm 4,6

Heading and footer: different for odd and even; different for the first page

Heading cm 4,3

Footer cm 5,3

Gutter 0

The text is therefore 11,8 cm wide and 18,5 high. The page number is centered at 0,8 cm starting from the foot of the last line.
