Anne Kwaschik, Constructing Difference: Feminist Witch Discourses in the 1970s

It is a well-known fact, that in the 1970s, feminist activists reappropriated the figure of the witch in various ways as a symbol of alterity, political radicalism, feminist revolt or victimhood, or the presentation of subversive (healing or body) knowledge. The article investigates the construction of this «artificial myth» in the early 1970s within different milieus of the emergent women's movements based on the examination of three feminist magazines and health guidebooks. «Die Hexenpresse. Zeitschrift für feministische Agitation» (1972-1976) in Basel, the West Berlin health guide Hexengeflüster. Frauen greifen zur Selbsthilfe (1975), and the artistic-literary journal «Sorcières. Les femmes vivent» (1975-1982) in Paris are read as sites and tools of alternative knowledge production. The article aims at demonstrating the new witch myth as a matrix of «knowledge empowerment».

Elisa Guida, Nelo Risi. Elementary thoughts for a biography between history, cinema and civil literature

This essay shows the first results of a research aimed at reconstructing the biography of Nelo Risi (1920-2015), a poet and director. A transversal reading of the poetic production between the second postwar and the mid-1970s is proposed. More specifically, the connection between language, history and contemporaneity is investigated. Then, the analysis follows a similar path to the one undertaken for poetry, and it focuses on Nelo Risi's documentary and film production. The profile of an artist still too little known will emerge, one who was able to unfold the second half of the Twentieth Century in its political, cultural, historical, and memorial interconnections.

Federico Goddi and Isabella Insolvibile, After Kefalonia. For a history of the memory and captivity of the Acqui Division soldiers

After the armistice between Italy and the Allies on 8 September 1943, the largest massacre of Italian soldiers during the Second World War by German troops took place on the Ionian Islands. The article reconstructs the captivity experiences of the survivors of the Acqui Division through the use of institutional, memoir, diary and epistolary sources. Particular attention is paid to the events of the "double captivity", first in German hands and then in Soviet hands. The analysis of the sources reveals the multiple identity of the veterans shaped within the different "seasons of remembrance" of Republican Italy.

1968: he transformed the movement into a reality attentive to the sensitivities of young people and the pacifist demands matured in civil society.
