Maria Paola Del Rossi, The Trades Union Congress and Europe: from the debate on joining the Eec to the Maastricht Treaty (1961-1992)

The essay reconstructs the role and action played by British Labor movement in Europe from the start of the debate on Britain's entry into the Eec in the 1960s to the Maastricht Treaty. Taking into account the British peculiarity in relation to the European integration process, the essay firstly analyses the relationship between the Labor movement and Europe from the signing of the Treaties of Rome to Britain's entry into the Eec in the 1970s; secondly, the essay observes the role played by the Tuc in the process of building the European Trade Union Confederation and its evolution; finally, it delves into the regaining in the 1980s of a political space for action for the Tuc in Delors' social Europe, after the marginalization imposed by Thatcher.

Instead, Fo and the Cfdt, even if they were not identical in their approach to Europe over the years, have demonstrated more dispositions. If Fo was a militant of the European cause at a time when Europe was considered a bastion against communism, the Cfdt had a particular trajectory and a role of primary importance, especially

It also intends to demonstrate how listeners of the BBC Italian Service felt part of a global community of ordinary people who shared similar lives and political views. After defining what transnationalism means, both old and new historiography on the BBC is reviewed to underline how approaches to the study of the corporation have changed over the decades. In the second part of the article, the papers of the broadcaster Elio Nissim will be analyzed as a case study to explain how the BBC managed to exert its soft power on both Italian broadcasters and listeners while concurrently carrying out its propaganda.
